Pensacola Navy League Perseveres from Hardship, Hurricanes and Heartbreak

he year 2020 has been especially challenging for the Pensacola Navy League. COVID-19 restrictions prohibited military interaction and canceled many events this year, including the opportunity to host two ship commissionings. Most recently hurricanes, in particular hurricane Sally, added to the fray, severely damaging the building where the Navy League office was housed. Many members, including our President Dan McCort, USN (Ret), sustained significant damage to their homes.

One year ago, the Pensacola Navy League Admirals' Club had the good fortune to have local historian John Appleyard present during a guest speaker series luncheon. Mr. Appleyard, a gifted storyteller, spoke on the history of NAS Pensacola.


- sacola's rich history. He authored more than 120 books and was 10 an avid baseball fan. At the age of 95, he received a five year con-

PRESIDENT'S MESSAGE CAPT Dan McCort, USN (Ret) President, Pensacola Navy League



G reetings to all. With the heat of summer beginning to fade, the cool refreshing days of Fall at hand and football back on TV, life seems to be almost "normal." Even better, some of NAS Pensacola's COVID restrictions are being eased allowing our Sea Service personnel to get off of the base and participate in select activities again.

The past quarter has seen the significantly increased footprint of the United States Coast Guard on board NAS Pensacola. First, the Cutter DILIGENCE arrived, tying up at NAS Pensacola on Monday, July 27th. Skipper Luke Slivinski and his crew were enthusiastically welcomed by a hearty group of Pensacola Navy League members, media, dignitaries and an official party from NAS Pensacola. All of whom braved the elements to greet the good ship and her crew in style. Second the Cutter RELIANCE arrived aboard NAS Pensacola Monday morning, August 31st, to the delight of waiting families,

a Navy League contingent, dignitaries and the U.S. Navy official party lead by CAPT Kinsella USN, Commanding Officer of NAS Pensacola. On arrival, Commander Robert Hill, Commanding Officer of the RELIANCE expressed his delight to have Pensacola as their new home and relief to have the Home Port change complete. In between those arrivals, the Buoy Tender, U.S. Coast Guard Cutter CYPRESS, Commanded by LCDR Chris Bonner, USCG, departed NAS Pensacola for an extended maintenance period up in Baltimore, Maryland. In an unusual move, the Crew from the CYPRESS returned to Pensacola after delivering their Cutter to Baltimore and will remain here in Pensacola without a ship until spring. The former CYPRESS Crew, now back in Pensacola, is awaiting their replacement Cut-

ter, the U.S. Coast Guard Cutter WALNUT, to finish its own maintenance availability. When that availability is complete this spring, the Crew will travel back to Baltimore to pick up their new "ride" the Cutter WALNUT and return her to NAS Pensacola. This will complete the Homeport change for both Cutters. Having served Pensacola and the Gulf Coast diligently and well for many years, we wish the Cutter CYPRESS and its replacement Crew the best in their new home. When the Cutter WALNUT sails into the port at NAS Pensacola this spring, we hope that you will join us in welcoming her to the Gulf Coast and beautiful Pensacola.

On Friday, August 7th, we had the bittersweet opportunity to say farewell to both Mr. Stu Ramsey of Pen Air Federal Credit Union and CMDCM Mario Rivers USN, the Command Master Chief for NAS Pensacola. Fair Winds and Following Seas

uring a dinner event held at the District Steakhouse on September 23rd, the Pensacola Navy League celebrated the brief return of CAPT Kevin Meyers, USN, the former Commanding Officer of the newly commissioned USS

Tripoli, LHA-7. CAPT Meyers made a stop in Pensacola while enroute to his new duty station in Washington D.C., where he assumed Command of the combined NROTC unit at George Washington University.

After successfully seeing the USS Tripoli through her Commissioning and transit to San Diego, CA, the Tripoli's new homeport, CAPT Meyers shared stories of the Commissioning challenges and his crew's incredible journey along the southern tip of South America through the Straits of



Magellan. Coincidentally, Tripoli's voyage occurred exactly 500 years after Ferdinand Magellan and his fleet discovered a passage to the Pacific in October 1520, now known as the Straits of Magellan. Juan Sebastián de Elcano took command following Magellan's death in 1522 and completed the fleet's circumnavigation of the earth. The Spanish Royal Navy tall ship Juan Sebastián de Elcano, which was named in his honor and is used to train Spanish Naval Academy Midshipmen, has visited Pensacola many times, most recently in 2015 and in 2019.

The USS Tripoli Commissioning Committee led by RADM Don Quinn, USN (Ret) presented plankowner plaques and coins for each crew member of the Tripoli and for each member of the Admirals' Circle, the top fundraising supporters of the Tripoli Commissioning. The USS Tripoli was originally scheduled to be commissioned in Pensacola, before COVID-19 restrictions precluded that opportunity. The plaques and coins were presented to the crew, while at sea, by CAPT Meyers.





The Coast Guard Cutter DAUNTLESS and crew returned to their homeport in Pensacola after a 56 day patrol where they intercepted and seized more than \$59 million in cocaine.

The Coast Guard says after the DAUNTLESS crew helped in relief efforts near Lake Charles, Louisiana following Hurricane Laura, they passed through the Panama Canal and helped in combating the transport of illegal drugs.

While working with interagency assets, the DAUNTLESS crew interdicted and seized approximately 3,500 pounds of cocaine.

"Every DAUNTLESS shipmate put forth an astounding amount of effort to overcome challenges presented by the COVID-19 pandemic as well as hurricanes Marco and Laura to ready themselves and the cutter for the counter-narcotics mission," said CDR Paul S. McConnell, USCG, DAUNT-LESS' Commanding Officer. "Their preparation and effort resulted in the successful execution of multiple interdictions. I am proud of the crew's accomplishments, and grateful for the sacrifices of my shipmates and their families back home, who have been enduring the ongoing effects of the COVID-19 pandemic and rebuilding in the wake of Hurricane Sally, which made landfall near Pensacola, Florida, while DAUNTLESS was underway."

The Coast Guard, Navy, Customs and Border Protection, FBI, Drug Enforcement Administration, and Immigration and Customs Enforcement, along with allied and international partner agencies, play a role in counter-drug operations.

This patrol marks DAUNTLESS' second operational patrol during the COVID-19 pandemic.



Cpl. J.R. Spears, USMC Remembered on 15th Anniversary of his Death



On Saturday, October 24th, the CPL J.R. Spears Detachment 066 of the Marine Corps League, the Military Order of the Purple Heart 566 and the Veterans Memorial Park Foundation held a remembrance ceremony in honor of the life and legacy of Lance Cpl. J.R. Spears, USMC.

Jonathan Ross "J.R." Spears, age 21, was killed October 23rd, 2005 in Ramadi, Iraq, by a single gunshot wound as he scrambled toward a buddy wounded by a grenade. Corporal Spears was the first-born and only son of Marie and Tim Spears of Molino, FL.

The ceremony, held graveside at Barrancas National Cemetery and Veteran's Memorial

Park was attended by Cpl. Spears' family and fellow Marines and friends. Lt. Col Andrew Del Gaudio, USMC (Ret) served as speaker.
