ARLINGTON, Va. — The Navy League of the United States announced that it has opened its membership to active duty service personnel, from every branch of the military, to join the organization as individual members. This historical change in the Navy League's bylaws, passed by its board of directors, has shifted its membership from an all civilian organization to a joint civilian and active duty organization. The Navy League currently has 30,000 members in 200 councils around the globe.

NAS Pensacola Change of Command

Beautiful Change of Command and Retirement Ceremony was held at the Naval Aviation Museum on January 12th, for CAPT Timothy "Lucky" Kinsella, USN (Ret) who was relieved from duty by CAPT Terrence "Village" Shashaty, USN.

CAPT Kinsella left a remarkable legacy in his 3 years as the Commanding Officer of NAS Pensacola. His strength and resilience during a catastrophic hurricane, a pandemic and the horrible acts of terrorism on December 6th, 2019, are just a few of the reasons he was recognized by the Navy League of the United



States for the prestigious John Paul Jones Award for Inspirational Leadership.

At the conclusion of the retirement ceremony portion of the program, CAPT Kinsella sang the traditional Irish song "The Parting Glass" prior to his "Piping Ashore" with his family.

Kinsella served as the commanding officer since March 2019 and led the base following a terrorist attack that resulted in the death of three Sailors and injured eight individuals, a global pandemic that threatened the mission of NAS Pensacola and category 2 Hurricane Sally that caused extensive damages to the installation. With Kinsella's leadership, NAS Pensacola managed to limit the effects of these events to base operations.



"NAS Pensacola faced some difficult challenges over the past few years, but I am so proud of how everyone on base, active duty service members and civilian employees alike, came together and faced these challenges head on with grit and determination," said Kinsella. "It's been the greatest honor of my life to be the commanding officer of this historic installation, but it was the people of this base that truly inspired me every single day I put on my uniform."

For his outstanding leadership and service to NAS Pensacola, CAPT Timothy Kinsella received the John Paul Jones Award for Inspirational Leadership in 2021, from the U.S. Navy League of the United States. The John Paul Jones Award for Inspirational Leadership is awarded to the Naval officer that has made an outstanding contribution to the high standards of leadership in the Naval service.

Kinsella was a steward for improving the education in the local area for not only active duty family members, but for all families in the community. Through his efforts, NAS Pen-

sacola was awarded a Department of Defense STARBASE program. The program, which will be located at the National Flight Academy onboard the installation, will allow fifth grade students



from Title I schools in the local communities to have a place to learn STEM (Science, Technology, Engineering, and Math) related topics starting in January 2022. Pensacola State College is also opening a charter high school near NAS Pensacola in 2022 that military children will be able to attend.

"I want to show children in Pensacola the art of the possible," said Kinsella. "It is my hope that STARBASE Pensacola and the charter school will inspire students to unlock their potential and achieve more than they thought possible. Pensacola is an amazing community and has always had a strong relationship with the installation. As the installation improves, so does the community and vice versa. This bond between the community and NAS Pensacola is what makes Pensacola a special place. When we work together, that's when

the magic happens!"

Shashaty, a Brooklyn, New York, native and a graduate of the U.S. Naval Academy, is reporting to NAS Pensacola following duty with the Joint Chiefs of Staff as the electronic warfare branch chief for the Deputy Directorate for Global Operations. Like all Navy aviators, Shashaty began his aviation training at NAS Pensacola and earned his pilot wings in 2000. Throughout his Navy career, he flew the EA-6B Prowler and EA-18G Growler and has over 400 combat hours in Iraq and Afghanistan. "I am excited about this opportunity to be the commanding officer of NAS Pensacola," said Shashaty. "I started my aviation career here and look forward to building on the outstanding achievements of the NAS Pensacola team. Every person, military and civilian, on NAS Pensacola plays a vital role in our mission and together, as a team, we will achieve great things."

Fortunately for the community, CAPT Kinsella will remain in the Pensacola area and vows to stay active in the Pensacola community.

"I have had a wonderful and fulfilling career in the Navy and this has been the absolute highlight, but now it's time to start the next chapter of my life and focus on my family," said Kinsella. "We have made lifelong friendships here in Pensacola and it's always felt like home to us, so it's an easy decision for us to stay. No matter what the future holds, I will always be proud to say that I was the commanding officer of NAS Pensacola."

C APT Terrence "Village" Shashaty, USN, assumed Command of NAS Pensacola on January 13th, 2022. The Navy League Admirals' Club wasted no time in asking him to speak at the year's first "Meet the Boss' Speaker series luncheon, held February 1st.

CAPT Shashaty shared some of his Pensacola area history and background, who, as a native of Brooklyn, NY, started his flight training at NAS Pensacola and NAS Whiting Field. Later, he worked as a flight line tour guide at the National Naval Aviation Museum aboard NAS Pensacola.

CAPT Terrence M. Shashaty is a 1998 graduate of the U.S. Naval Academy. He also holds a master's degree from the U.S. Naval War College.

Designated a Naval Aviator in October 2000, CAPT Shashaty completed four operational carrier deployments flying the EA-6B Prowler. During his first tour with the "Scorpions" of VAQ-132, he deployed onboard the USS

George Washington (CVN 73) and the USS John F. Kennedy (CV 67). Following his first shore tour, he transferred to Carrier Air Wing TWO (CVW-2) and served as Air Wing Landing Signal Officer (LSO) and Safety Officer, deploying onboard USS Abraham Lincoln (CVN 72). For his department head tour, he served as Safety Officer, Maintenance Officer, and Operations Officer, completing a deployment onboard the USS Enterprise (CVN 65) with the "World Famous Rooks" of VAQ-137. On his most recent operational deployment as the Commanding Officer of the "GARUDAS" of VAQ-134, CAPT Shashaty oversaw the transition to the EA-18G Growler and led its inaugural expeditionary deployment to the Indo-Pacific area of responsibility.

CAPT Shashaty's shore tours include instructor duty at VAQ-129, serving as FAM/NAV Instructor, Schedules Officer, EA-6B NATOPS Evaluator and Carrier Qualification Phase Head. He also served as a Joint Maritime Plans Officer assigned to United States Northern Command, where he planned, coor-





dinated and executed joint and interagency support in response to requests for assistance from civil authorities for domestic emergencies. Prior to his assignment as Commanding Officer of NAS Pensacola, Shashaty completed his tour on the Joint Staff, Deputy Directorate for Global Operations as the Electronic Warfare Branch Chief.

His accomplishments include recognition as Commander, Electronic Attack Wing, Pacific's LSO of the Year for 2005 and Commander, Naval Air Force's LSO of the Year for

2009. Additionally, the "GARUDAS" received recognition as the 2017 Battle Efficiency and Arleigh Burke Award winner during his time as Commanding Officer.

CAPT Shashaty has accumulated over 2,500 total hours (1,800 EA-6B hours, 400 FA-18E/ F/G hours) and over 400 combat hours in support of Operations Southern Watch, Enduring Freedom, Iraqi Freedom, and New Dawn. He has totaled over 500 arrested landings on seven different aircraft carriers and has received multiple individual and campaign awards including the Defense Meritorious Service Medal (2 awards), Meritorious Service Medal, and Strike/Flight Air Medal (3 awards).



In his remarks, CAPT Shashaty said his top three most important goals are family, mission and

CAPT Shashaty and his lovely wife Jennifer have four children, Christopher, Nicholas, Matthew and Elizabeth.

The family's new home aboard NAS Pensacola proudly diplays a painting that was previously displayed in the NASP Naval Aviation School's Command in building 633, the site of the terrorist attack of December 6th, 2019. The painting depicts the EA-6B Prowler, with a tail code for the "Scorpions" squadron, the same type aircraft Shashaty flew with the "Scorpions" following his designation as a Naval Aviator. The painting also has a tear in it, caused by a stray bullet from that fateful day in Bldg. 633.

Shashaty says the painting is a powerful reminder of the resilience of the great people under his command.

More than 65 people attended the event.



It is with great sadness we report the passing of long time Navy League supporter and friend Gerald McGill.

From Mark Curley, President of the Pensacola League: "Anyone who spent more than a few minutes with Gerry quickly became aware that the Coast Guard was his passion. How fitting then, that as word of an impending visit to Pensacola by the Tall Ship, USCG Cutter EAGLE circulates that we will be able to honor Gerry by providing that special ship and Crew the very support that Gerry would have loved to provide personally. His spirit will certainly be on deck as that beautiful Cutter pulls into port. Please offer your prayers and support to the McGill family. Semper Paratus Gerry!"

Gerald received an appointment to the United States Coast Guard Academy, from which he graduated

in 1965 with a degree in mechanical engineering.

In 1967, Gerald volunteered for a tour of duty in Vietnam. As the Commanding Officer of the Point Welcome, an 82-foot Point-Class Coast Guard Cutter, Gerald participated in Operation Market Time, and was awarded the Bronze Star with Combat "V" for his service to his country. He was honored to be selected for placement on the Wall of Gallantry at the United States Coast Guard Academy. As a lifelong advocate for the Coast Guard, he treasured his friendships with his band of brothers.



Upon returning from the war, Gerald attended Catholic University Law School in Washington D.C. where, in 1969, he met the love of his

life, fellow law student Maureen Logue. They married in 1971 and moved to Pensacola in 1977, where they would go on to raise their two daughters, Erin and Stephanie. Gerald enjoyed a very successful career as an attorney, becoming well-respected throughout the Gulf Coast as an expert on admiralty and maritime law.

Gerald will be remembered as a gifted storyteller and as someone who never met a stranger. He

was always eager to help anyone in need, and he was known for keeping a cool head in a crisis. His motto was, "five minutes early is on time; on time is late."

In addition to his wife and daughters, Gerald is survived by his grandsons, Logan and Luke Glover, Landen Sudduth, and Liam Nobles, as well as his granddaughter, Madeline Nobles.

In lieu of flowers the family requests memorial donations be made to the March of Dimes, St. Jude's Hospital for Children or the Wounded Warrior Project.





The Pensacola Navy League has been recognized by the Freedoms Foundation at Valley Forge for a mask-making project held in April 2020!

In March 2020, a new DoD/CDC directive required that all personnel aboard military installations wear a "face mask" at times, when distancing is not possible. Unfortunately there were no face masks available to issue those personnel. Service members were being told to make their own masks, specifically from T-shirts. A plea to the Pensacola Navy League membership resulted in more than 1600 handmade masks created and donated by volunteers under the coordination of Carol Monroe. The masks were delivered in two batches to the NAS Pensacola Naval Aviation Schools Command (NASC).

JOIN THE PENACOLA NAVY LEAGUE

We welcome everyone to join our Pensacola Navy League and participate in our Council Events. Many of our activities offer both member and nonmember prices. The non-member price option is for those not yet ready to join, but interested to see what the Navy League is all about. Additionally, Membership in the Pensacola Navy League offers perks to our members as a function of their level of membership. Examples of such perks include; invitations to free events, discounted tickets to special events, recognition, and more. In order to join and participate in the local Pensacola Navy League, membership with the National Navy League is a prerequisite. Visit our website for details and to join http://pensacolanavyleague.org/members

The categories of membership in the Pensacola Navy League are:

Regular Member – Any citizen of the United States desiring to support and advance the objective and purpose of the Navy League shall be eligible as a Regular Member. Active Duty members of any branch of the armed service persons are not eligible for membership while on active duty. Reservists are eligible for membership, but while on active duty are not eligible to vote or hold a Navy League office.

Honorary Member – Any outstanding person who has shown and expressed unusual interest in this Council and who has made significant accomplishments at local, regional, or national level of the Navy League shall be eligible for Honorary Membership upon unanimous approval of Council Members present at a regular monthly meeting. No dues shall be assessed against such Honorary Members. Honorary Members are privileged to take part in all social activities of the Council but shall not be eligible to vote or hold regular office in the Council.

Associate Member – Non- citizens may be Associate Members provided that they are proposed by a Council and not by an individual. An Associate Member shall be entitled to vote and hold office at the Council level, with the exception of serving as Council President. Current annual dues structure applies.

Guest Member – National Members who are not dues paying Local Members shall be designated as Guest Members. These members will receive invitations to local events but charged a higher cost than Regular Members. Guest Members shall also be eligible to receive the Bullhorn Newsletter via e-mail.

Spouse of Active Duty Personnel – Active Duty Spouses are eligible for either a FREE E-membership or a regular membership at a reduced rate; however, they may neither vote nor hold office. The offer of a free E-membership has been extended from 2020 until the end of 2021.

Community Affiliate Membership – Community Affiliate Membership is designed for companies whose business is primarily local rather than national in orientation, whose primary interest is in the activities and concerns of the local Council and desire to support and advance the mission and objectives of the Navy League. During each year of membership, a Community Affiliate Member may designate up to four (4) Regular Members, provided such Members are otherwise qualified. Designated members enjoy all the privileges of individual Membership including the right to vote and hold office.

Members in Good Standing - Members whose dues are current shall be considered Members in Good Standing, and shall have all resulting rights and privileges of membership including the right to vote and to serve as Council Officers and /or on the Council Board of Directors.

General - Each applicant for membership shall be presented to the Board of Directors for approval. Upon approval, the Executive Secretary will provide the National Headquarters with appropriate documentation and national dues, if appropriate
